Proposed Tree Cutting Bylaw for SSA Property and Administered Properties

August 14, 2014

1. We believe that, since the SSA is a Conservation Club, the wooded portion of the property should be managed for wildlife (of all types, including birds). It should be noted that this is consistent with our Managed Forest Tax Incentive Plan.
2. Our by law regarding tree cutting should be very restrictive. This means that no cutting may occur without being submitted to the WAC for recommendations to the Executive and General Members.
3. There are a number of good reasons for tree cutting which may include hazards to people and existing property as well as conservation cutting to free fruit bearing trees (e.g. old apple trees) for wildlife. Any tree cutting must not conflict with our conservation policies. Some standing dead trees are very beneficial to wildlife and birds (e.g. den trees for raccoons)
4. It should be noted that this bylaw does not prohibit tree trimming on existing trails and roadways or tree cutting in order to maintain our range certifications (as required by the C.F.O). Additionally, due to insect infestations, Ash tree cutting is exempt from this bylaw.
5. If any other exception to this bylaw is required, prior notification in two newsletters must be given. The Motion must be passed by a 2/3 majority in order to be accepted.

This proposal must be read at 3 successive general meetings before it is voted on at the January 2015 meeting, First reading occurred at the October meeting.

Seeing them all in one flock would be a lot of birds.

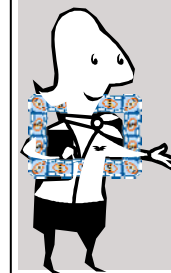

## Gun Courses

There will be no more gun courses until after the snow leaves. The first Non Restricted course will probably be late April or May. Restricted courses will depend on demand for them but I would like to put on at least one in 2015.

I would also like to run a Ladies Only course. I ran one a few years ago and IF I CAN get five interested Ladies I will run one this coming year.

The cost for any gun course is as follows.

Registration Fee \$ 35.00 ( non refundable) This pays for the book And the tests. Payable at time of registration.

Course Fee \$ 50.00 for Members. \$ 85.00 for NON Members , \$ 35.00 for Jr Members  
\$ 50.00 for NON Members Under age 18.

The Course Fee is in addition to the Registration Fee and is payable on the first night of the course.

There have been some changes to the Firearms Act that members should be aware of.

NO ONE under the age of 18 may challenge the Non Restricted Firearms Test or Restricted Firearms Test. They have to take the appropriate courses.

There is also legislation in the works that IF PASSED will mean that NO ONE will be able to challenge the tests PERIOD. This means that first time gun owners will Have to take a Firearms Safety Course to LEGALLY POSSESS Firearms.

## Chronic Wasting Not Detected in Local 2014 Deer Survey

Almost 550 head tissue sampled and tested revealed no evidence of chronic wasting disease (CWD) in Bruce-Grey-Huron whitetail deer examined by MNRF biologists during the 2014 fall hunting season. The geographic area sampled included the Bruce Peninsula south to the Grand River – Exeter area, specifically Wildlife Management Units 82A, 82B, 83, 84, 85A, 85B and 85C.

As a result of this latest survey, Ontario biologists are again, breathing a sigh of relief given the fact chronic wasting is not that far away geographically. It's already been found, primarily in captive populations in such neighbouring US states as Michigan, New York, Pennsylvania and Wisconsin. And just recently, for the first time, the disease was discovered in the state of Ohio. The state of Iowa also revealed in 2014, the confirmation of CWD. A total of 14 US states have now determined the presence of this deadly disease.

This neurological scourge, fatal to whitetails, elk, moose and woodland caribou, has the potential to destroy entire populations. Unfortunately, CWD, a disease that attacks the central nervous system, is untreatable. There is no known remedy to the culprit – an abnormal protein called a prion, which invades the animal's brain cells, subsequently leading to progressive weight loss, abnormal behaviour, loss of appetite and body functions, and in the end, death.

Much of the spread of CWD in the U.S. can be blamed directly on game farms and the inter-state import-export trafficking of diseased animals.

**Rainbow Trout**

Rainbow trout numbers have by and large stabilized, with low mortality numbers being reported daily. Sometime before the snow flies, we will have to recapture the rainbows in the kidney pond, and clean the pond of the material that has accumulated since late spring.

**Brown Trout**

Brown trout numbers are virtually unchanged from one day to the next. The browns that are now in the hatchery will be held over winter and released next spring.

**Chinook Salmon**

Chinook salmon egg collection has been completed, and we now have approx.. 115,000 salmon eggs in the hatchery

**Limited Term Lease**

The lease has been signed by all parties, with electronic and hard copies distributed where necessary. Lease payment cheques have been sent to Jim Weaver for the balance of the year, and depending on how the land purchase work goes, we'll be issuing additional cheques in the new year.

Work is currently being done in getting a snow removal contractor on board, to fulfill the snow removal term of the lease.

**OWEN SOUND MILL DAM FISH LADDER**

On and off over the last two years, discussions on egg collections and fish stocking activities with Jody Scheifley have touched on the condition and design of the Mill Dam Fish Ladder. Jody has mentioned that we (non-specific) should be looking at replacing the fish ladder with a new one that is designed to move fish above the dam in a manner that is less damaging to the fish, more easily ascended by egg laden large females, and easier to work in during hatchery egg collections.

I discussed the idea a little more with Jody, this week; to get a feel for what is involved, how it would get started, parties involved, costs, etc. This project would be riddled with almost endless red tape, permits and applications, studies, assessments, design modifications, cost estimates, etc. As far as money is concerned, it would be totally funded by the MNR, since they have ownership of the fish ladder (estimated total cost of \$1,000,000 PLUS). The process would involve not only the MNR and the MOE, but also partners like the Grey Sauble Conservation Authority, the City of Owen Sound, and the Sydenham Sportsmen's Association. The actual construction of the fish ladder wouldn't take very long, but everything leading up to it would probably take several years.

Jody is in the process of getting a piece of equipment that will measure the water flow inside fish ladders, and he believes that what is needed at the very start is data to be collected at the Mill Dam with respect to water flow inside the fish ladder as well as water temperatures at the dam itself. If we would be willing to participate in the collection of this data (helping him and his staff when necessary), he will show us how to use the equipment, and between him and use, get the process started. This work will be done in the spring during what would be the Rainbow trout run, and again in the fall during the Salmon run. The data would be used to determine how well the fish ladder is working, if there is a problem, whether a modification would correct it, or if an entirely new ladder would be required. He will keep me posted as to when the equipment becomes available, and when help from us will be required.

**GREY SAUBLE CONSERVATION AUTHORITY**

The Grey Sauble Conservation Authority, Owen Sound Tourism, and Sydenham Sportsmen's Association first annual "Fish Tasting and Spawning Bed Tour" fund raising project that took place on Oct 4th, 5th, 11th, 12th, and 13th is now history. All indications are that in spite of the cold and wet weather conditions, the event was well received by the general public that came out to see and learn about Chinook salmon and the fishery in Owen Sound and the surrounding area. Chris Hatchey was quite pleased with the number of visitors to the event, but hasn't as yet gotten back to the committee on the financial numbers. From what I've heard and seen, I'm confident that we will see a return that not only covers the monetary value of the salmon we donated, but should also contain a reasonable profit component as well

On a slightly different note, I would like to inform the board and FAC that the Conservation Authority is looking at rebuilding / repairing / reconditioning the spawning channel located directly behind their administration building. During the fundraiser, it became quite obvious that the channel wasn't even close to being utilized to its full potential, and definitely not up to the expectations of the event. Luckily we could show the public our spawning channels and the salmon that were utilizing them. I've walked the full length of the CA's channel, and couldn't find any more than three or four fish in it, at any one time. After a brief discussion with Chris about the condition of the spawning channel he instructed his people to put a reconstruction component into the Conservation Authorities next budget. If the SSA is willing to provide guidance and instruction, along with some manpower they will get some of their own workers and volunteers together, to work with us in getting the channel in a condition suitable to spawning activity. We'll get in touch with Chris sometime in the new year to see how things play out with their budget.

### SSA FISH HATCHERY TOUR

A hatchery tour for representatives from the Stewardship and Conservation Incentives Section of the Peterborough Ministry of Natural Resources and Forestry went very well. They not only toured the hatchery, but also went to the Side Channel Spawning Beds, to view the work we do at that location as well. All of them were impressed with what they saw and heard about our activities relating to the local fishery, in both a hatchery and wild setting.

### SCHOOL SALMON HATCHERY PROGRAM

The two schools in Owen Sound are now prepared to receive the eggs once they can be transported. I have picked up the egg incubator trays from the schools and am now simply waiting for the eggs to eye-up so that I can get them placed in the school's aquariums.

### COLDWATER FISH DISEASES WORKSHOP – UNIVERSITY OF GUELPH

The workshop was an extremely interesting and informative event. We got first-hand experience in fish dissection, disease diagnosis, and guidance in what to when fish are sick and/or dying. Guidance was given as to what to do in certain circumstances where treatment can be done on site, as well as what to do when in-house treatment doesn't produce positive results. Ron Robb has decided that he will be the SSA Fisheries Physician and treat the disease where and when possible, as long as I determine the illness or cause of death; virtually becoming the SSA Fisheries Coroner (the dirty end of the stick again).

### FMZ 14 & 13 MEETING

The next FMZ Meeting will be a joint meeting of Zones 13 and 14. It has now been confirmed that the meeting will take place in Sudbury, on Saturday, November 29th.

### ROGERS TV / HISTORY LIVES

We completed the History Lives program with Rogers TV during the Salmon Egg Collection Activities at the Mill Dam. It dealt with the activities at the dam, various SSA fisheries activities and projects, as well as the importance of the Owen Sound Salmon Spectacular to all the things we do as a Conservation Minded Organization. Haven't seen it on television, but look forward to seeing the DVD they are sending us on this subject, along with the interview they did with Jack Osadzuk on the History of the SSA.

## FAC REPORT – November 20, 2014

### FISH HATCHERY

Hatchery operations are fairly routine at this time of year; feed the fish, clean the tanks, remove the dead, keep an eye open for disease, update records, and make sure all the hatchery equipment is operating properly.

#### Chinook Salmon

Chinook salmon eggs have either hatched or are hatching at this time.

#### Hatchery Snow Removal

With the recent snow fall in our area, we are definitely into the winter season, and into the start of snow removal activity at the hatchery. As laid out in the new lease agreement, the onus is now on us to maintain the property in a safety and security condition; not only for ourselves, but also for the property owner.

#### OWEN SOUND MILL DAM

Water levels behind the Mill Dam have been lowered, in preparation for winter, and eventually the high waters of spring.

#### GREY SAUBLE CONSERVATION AUTHORITY / SALMON TOUR PROJECT

A wrap-up meeting has been scheduled for December 3rd, to go over the results of this years event, look at past operations and consider potential improvements that can be made to running the fund raiser again next year. At this point we know that the fund raiser realized a total net income of \$1,670.00, of which the SSA will receive \$835.00

#### CHP PROGRAM

The December 31st report submission date is coming up rather quickly, and I going to have to start pulling everything together and draft the actual report in about two weeks from now. The sooner I get my hands on the hatchery related invoices from April 1st, 2014, to date, the better. At the same time, I will need to determine how much, if any funding could still to be utilized. If there is potential to get more equipment for the hatchery, I need to determine what I can get, place the order and ensure that I get my hands on the appropriate invoice, to include it in the Dec 31st report.

#### YEAR END MNRF & MOE REPORTS / APPLICATIONS / PERMITS

Sometime between the first of January and the end of March next year, the 2014 Water Taking and Water Treatment reports will have to be submitted to the MOE. Early in the year, the Hazardous Waste Permit will be acquired from the MOE, and the Aquaculture Facility, Egg Collection and Fish Stocking Permits for 2015 will be obtained from the MNRF. 2015 is also the year when our current Water Taking Permit expires, and when we need to reapply for a new one, in order to keep operating our hatchery facility.

#### SCHOOL SALMON HATCHERY PROGRAM

Both Owen Sound public schools now have their 100 Chinook salmon eggs each, and are in the early stages of the program. If all goes well, between now and next June, they will be stocking out a relatively high number of smolts into the Sydenham River.

#### FMZ 14 & 13 MEETING

The next FMZ Meeting will be a joint meeting of Zones 13 and 14, in Sudbury, on Saturday, November 29th. Hopefully the weather doesn't get too crazy, and the meeting can take place as planned.

#### “IN DEPTH WITH RENO VIOLA”

I've agreed to do a telephone interview with Reno Viola for a segment of his show called “Conservation at Work”. The program deals with boots on the ground conservation or environmental projects done by the SSA and other like-minded groups across the province along with the benefits they provide to the great outdoors, and the surrounding communities. The details of the interview still need to be provided, but everything should be finished by the end of the month.

**Range Report - Shooting Sports      **Bill Douglas and Al Hillis****



We are continuing our in-house program to train more Range Safety Officers, the next course will be held on Dec. 7th here at our SSA Clubhouse. All those involved have been notified by separate invitation and as usual the participants are prepared to do your fair share of shifts down on the 100 yd. range. Naturally all SSA approved Range Safety Officers must pass the course and be approved by the Executive.

The archery range is still in good shape and the 3D targets on positions #10 through #20, have been taken in for the winter (just before the first snow). The regular Ames targets are still out there, so enjoy them while you can. We put down some chips on the soggy sections of the trail before the end of October so it won't be as wet or muddy come spring.
